

Memorandum of Understanding

Between

Bansomdejchaopraya Rajabhat University

Kingdom of Thailand

and

National University of Laos Lao People's Democratic Republic On Academic Cooperation



The Bansomdejchaopraya Rajabhat University, Kingdom of Thailand and National University of Laos, Lao People's Democratic Republic hereinafter referred to as "the Parties" have agreed to promote the intercollegiate cooperation. The Parties have reached the agreement as follows:

- 1. The Parties shall encourage the following activities:
 - 1.1 Exchange of faculty, staff members, research scholars and students;
 - 1.2 Joint research activities:
 - 1.3 Participation in seminars and academic meetings;
 - 1.4 Exchange of academic materials and others information.
- Specific agreements or Memorandum of Understandings for implementing this Memorandum of Understanding shall be signed separately after negotiation on the detailed programs between the Parties.
- 3. All activities resulting from this Memorandum of Understanding shall be governed by and in accordance with the laws and regulations of Lao People's Democratic Republic and Kingdom of Thailand. All agreements and obligations of the Parties are subject to the procurement and maintenance of all applicable government consents, permits, authorizations, and approvals.
- 4. This Memorandum of Understanding shall be governed by in accordance with the law and regulation of Lao People's Democratic Republic and Kingdom of Thailand as well.
- 5. This Memorandum of Understanding is valid for five (5) years and may be revisable or extendable by mutual consent. Either Party may terminate the Memorandum of Understanding at any time by written notice signed by appropriate official of the Party initiating the notice. The notice must be received by the other Party at least six months prior to the effective date of termination. The termination of this Memorandum of Understanding will not affect the implementation of on-going activities and/or programs undertaken pursuant to this Memorandum of Understanding, prior to the date of termination of this Memorandum of Understanding unless otherwise jointly decided upon by the Parties.
- 6. Any dispute or differences arising out of the interpretation or implementation of this Memorandum of Understanding shall be settled amicably through consultation between the Parties.
- This Memorandum of Understanding shall be effective, when the representative of the Parties have affixed their signatures.
